Terms and Conditions of Party Planner Agreement:

As A Tickled Pink Party Independent Planner I understand and agree:

1. I will promote and sell A Tickled Pink Party products by hosting in home parties for children. I will not buy products for resale with the intent to sell them in a retail establishment or over the internet. I will represent the company in a truthful and honest manner. I will be reliable, professional, and present myself in the highest quality to maintain the standard of excellence set forth by the company.
2. I will protect the Company's trademarks and trade names, by not reproducing any of the company's materials or names without written approval from the company.
3. I understand I am an independent contractor. I am not part of a franchise, employee, or owner in the company. I do not have authority to negotiate any contracts, take on any debts, or in any other form act on behalf of the company.
4. As an independent contractor, I am responsible for any and all self employment taxes, federal taxes and any other filings required by law. I understand I am not covered for any State Unemployment or Workers Compensation Act. I agree to abide by all Federal, State and local laws that pertain to my A Tickled Pink Party Business.
5. I will present the company's business opportunity truthfully. I will make sure those I speak to are at least 18 years of age.
6. I will submit orders to the company paid in full, by check or credit cards. I understand no order will ship without approval of the company.
7. I understand the information and materials I receive are property of the company and will be confidential, unless written approval is granted by the company.
8. I will only use, sell, or demonstrate, A Tickled Pink Party products at any parties or events where I am there to represent A Tickled Pink Party. This includes any other purchased or self made products.
9. I authorize Tickled Pink Parties, Inc. DBA, A Tickled Pink Party, to release my name, telephone number and e-mail address in response to a customer request. I will notify the company in writing if I do not wish to have such information released. The address for such request is 831 Auburn Rd. Suite 120-307, Dacula, GA 30019. In an effort to maintain the highest customer satisfaction, I agree the company will direct this customer to another planner in the area.



Tickled Pink Parties, Inc. DBA, A Tickled Pink Party agrees:

1. The Company will pay commissions based on the wholesale volume of the individual or group as submitted in orders.
2. The Company will also pay incentives, rewards, or grant additional privileges to “active” Party Planners. An active Party Planner is someone who submits at least 2 parties, in a continuous 3 month period. The company reserves the right to waiver the personal sales requirement.
3. The Company will pay a qualified Party Planner overrides when the party planner has 2 or more personally recruited qualified party planners, based on submitted commissionable orders.
4. The Company will calculate and pay all commissions and overrides, based on the most current published compensation plan. The Company will provide 30 days written notice to the Party Planner before making any changes to the compensation, reward, or incentive programs.
5. The Company will not set “local” geographical territories for Party Planners, however you are required to do business in the United States, and other territories of the United States.
6. Upon termination of this agreement, The Company agrees to accept return of any unused re-saleable merchandise within 30 days, with a 10% re-stocking fee, based on the purchase amount as listed on original sales order.
7. The Company will re-instate a Party Planner to “Active” status, if a Party Planner orders \$150.00 or more within 12 months of inactivity.



General:

1. This agreement is subject to acceptance by Tickled Pink Parties, Inc. based in Dacula, GA. It is considered binding by accepting your Party Planner kit.
2. This agreement is effective for 12 months. I will be automatically renewed for an additional 12 months at the terms of the current year.

Either party may terminate this agreement at any time with 30 days written notice to the other party.

3. This agreement can only be changed, altered or modified in writing by an authorized representative of the company.
4. This agreement shall be governed by the State of Georgia for all of matters.
